IM Pediatric Best Practices



Course Description:

This self-study course leads to the Interactive Metronome Advanced Pediatric Designation (IMAP). Optimal treatment outcomes are more easily attained when there are appropriate accommodations for age, developmental level, group dynamics and environmental factors.
